1 Business Domain View

1.1 Introduction

Message Definition

Product Recall Notification Message Definition

The Product Recall Notification message notifies involved parties in the supply chain of the need to remove specific products (traceable items) which may pose a health and safety risk to consumers.

Product Removal Confirmation Message Definition

The Product Removal Confirmation message enables involved parties to confirm which products (traceable items) they removed from the supply chain based on the request in the Product Recall Notification.

Product Recall Closeout Notification Message Definition

Product Recall Closeout Notification enables the Product Recall Initiator to communicate that an earlier issued Product Recall Notification is no longer active / has been completed.

Principles

Organisations, consumer / end users and regulators in markets around the world have an interest in establishing a common method to recall products at various points of the supply chain. The need exists for a standard set of business processes and the supporting data, enabling traceability partners in a supply chain to quickly and efficiently initiate a Product Recall and track its progress through to its conclusion (meaning the identified product is no longer available in the supply chain).

This BMS is a part of the global GS1 standard for product recall enabling the effective communication and process to conduct a product recall.


















